



2. The representative of the society explained the view of the proposal before the committee and apprised that the team of Naveen Path(Regd.) Society intends to study extensively in Bastar District of Chhattisgarh to highlight the positive developments made in the field of tribal rights, livelihood, economical activities, traditional arts and crafts education and alternative income generation. He asserted that massive development work has been done in Bastar District. However, the international media prominently presents the murky picture of the District. The team will prepare an audiovisual Report of Bastar for Indian and International Audience, Coffee table book and also prepare two small films on Development in Bastar Region for screening on various TV channels.
