- 1. The First National Level Sports Meet for Eklavya Model Residential School (EMRS) students was held during the month in Hyderabad, Telangana wherein 20 States with 1777 tribal students participated.
- 2. As per information received from State Governments regarding implementation of Forest Right Act, 2006 till 30.11.2018, 42,24,951 claims (40,76,606 individual and 1,48,345 community claims) have been filed and 18,94,225 titles (18,22,161 individual and 72,064 community claims) have been distributed. A total of 38,33,456 (90.73%) claims have been disposed of.
- 3. Based on the recommendation of the Pricing Cell Constituted by the Tribal Cooperative Marketing Development Federation of India Ltd. (TRIFED), this Ministry has further decided to announce the inclusion of **nine (09)** more MFP items in the scheme along with their MSP which will be operative with immediate effect.
- 4. The meeting of the Project Appraisal Committee of this Ministry for approval of the proposals received from 2 States for SCA to TSS, Article 275(1) and Development of PVTGs was held during the month of January, 2019.
- 5. As per the information received "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs.88.09 crores as on 31st January, 2019 for the year 2018-19. The total Annual target for the year, 2018-19 is Rs.220.00 crores.
- 6. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.
- 7. During the month, the 9th Report of National Commission for Scheduled Tribes (NCST) for the year 2013-14 along with Action Taken Memorandum was laid in both houses of parliament.
- 8. During the month of January 2019, 103 E-files have been created by this Ministry in e-office.
