Monthly Summary of Principal Activities for October, 2019.

This is regarding important activities of Ministry of Tribal Affairs during the month of October, 2019.

- 2. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs.62.09 crores as on 31<sup>st</sup>Oct, 2019 for the year 2019-20, which is 156.46% more than corresponding month of previous year. The total Annual target for the year, 2019-20 is Rs.228.00 Crores.
- 3. As per information received from State Governments till 30.04.2019, 42,37,853 claims (40,89,035 individual and 1,48,818 community claims) have been filed and 19,64,048 titles (18,87,894 individual and 76,154 community claims) have been distributed. A total of 37,17,552 (87.72%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.
- 4. A Video Conference was held on 16.10.2019 with 24 States under the Chairmanship of Secretary (Tribal Affairs) to discuss on the proposed MoU to be executed between National Education Society for Tribal Students (an autonomous body under the Ministry) and the State Governments; expeditious operationalization of existing EMRS; modalities of construction and other issues.
- 5. A meeting co-chaired by Secretary (Tribal Affairs) and Secretary (Sports) was held on 18.10.2019 with the State Governments of Telangana and Mizoram regarding setting up of Centres of Excellence and other issues.
- 6. A meeting of the Committee on Centre of Excellence (CoE) under the Chairmanship of Secretary (TA) was held on 15.10.2019 therein organization/ Institutes/ University like FICCI, ANSI, CSSHP were recognized as CoE. The organization were given Research and Study Projects.
- 7. 2nd Meeting of Sub-Groups of Governors relating to the issues of Tribal Affairs was held on 11th October, 2019 at Pravasi Bhartiya Kendra, Chanakya Puri, New Delhi.
- 8. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.
- 9. During the month of October, 2019, 104 E-files have been created by this Ministry in e-office.
