Subject: Monthly Summary of Principal Activities for September, 2019.

This is regarding important activities of Ministry of Tribal Affairs during the month of September 2019.

- 2. A meeting of Sub Group of Governors related to the Tribal issues was held on 16.09.2019.
- 3. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs.48.74 crores as on 30th Sep, 2019 for the year 2019-20, which is 316.90% more than corresponding month of previous year. The total Annual target for the year, 2019-20 is Rs.228.00 crores.
- 4. As per information received from State Governments till 30.04.2019, 42,37,853 claims (40,89,035 individual and 1,48,818 community claims) have been filed and 19,64,048 titles (18,87,894 individual and 76,154 community claims) have been distributed. A total of 37,17,552 (87.72%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.
- 5. PAC meeting were held with 26 States for appraisal/ approval of annual plan/ additional proposal for the year 2019.20.
- 6. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.
- 7. During the month of September, 2019, 104 E-files have been created by this Ministry in e-office.
