Minutes of the meeting of National Level Committee held on 18th February, 2020 under the Chairpersonship of Secretary, Ministry of Tribal Affairs regarding assessment of construction of Freedom Fighters' Museum.

A meeting of the National Level Committee (NLC) was held on 18th February, 2020with representatives of the Government of Andhra Pradesh, Jharkhand, Madhya Pradesh, Manipur and Mizoram to assess the progress of work of construction of Freedom Fighters' Museum in respect of the States, which was sanctioned in previous years and appraise / approve new proposal of Mizoram. List of participants is at **Annexure-1**.

2. At the outset, the chair was informed about the status of fund released to the States where Tribal Freedom Fighters Museum has been sanctioned as under:

- 3. Thereafter, the status of construction of Freedom Fighter's Museums of States was reviewed by the Committee. The observations / decisions of the Committee were as under:
- 3.1 **Manipur:** The representative of the Manipur informed the Committee as follows:
 - 23.6 acres of land acquired by State Government at Makhel village in Senapati District and foundation Stone of "TRIBAL FREEDOM FIGHTERS' MUSEUM, MAKHEL" laid by Hon'ble Minister (TA&H) Manipur on 13th September, 2019.
 - 2. Notification for inviting EOI/ Architectural/Museum Design competition issued.

- 3. Letter to all Tribe Leaders (36 Tribes) were also sent in the same month inviting authenticated information about respective tribes.
- 4. Expert Committee comprising of historians and academicians from Manipur University under the ACS, TA&H is working on Tribal Freedom Movements and Tribal Freedom Fighters from the State and for validation and reconciliation of the tribal history as desired by the National Level Committee (NLC).
- 5. Storyline of the proposed Museum modified as advised by MoTA/NLC and special focus on contribution of Rani Gaidinliu & other women freedom fighters.
- 6. Display areas shall depict the life of prominent tribal freedom fighters mainly Rani Gaidinliu and her contribution.
- 7. Themes and Galleries of the Museum are broadly divided into two sections i.e. (1) Galleries on Tribal Freedom fighters from Manipur with special focus on Women's role and contribution (Rani Gaidinliu), and (2) Galleries on life, culture and tradition of all tribes of Manipur (tribal society).
- 8. All the galleries and display areas will have Interactive Touch Kiosks and auto sensor guided Audio-Visual facilities to engage the visitors individually and to enable them enjoy unique experience of sounds and digital displays, story of tribal engagements in freedom struggle etc.

3.1.1 The Committee observed as under:

State Government may review the site selection of the museum at Makhel village in Mao Maram tehsil of Senapati District in Manipur in terms of the following parameters:

- i. Available and proposed connectivity to the site from the State capital and District headquarter (Road, Rail, air).
- ii. Availability of electricity, mobile and internet connectivity at the site.
- III. Availability of infrastructure linkages at the site including hospital, hotels & restaurants, public transport facilities, ATM & Banking facilities, common service centre, market facilities, police station, fire services, etc.
- iv. How the proposed site is in sync with the local culture and history.
- V. How, having the museum located at the present site and the proposed plan for development / coverage under the museum adds value to the location as well as the purpose for which it is envisaged.
- Vi. What are the steps proposed to be taken by the State Government to promote tourism and enhance the footfall at the site chosen.
- vii. Timeline for the activities envisaged with reference to museum at Manipur including tentative timeline for completion of construction to be provided by the Ministry.

3.1.2 Decision of NLC

State Government to organise a field visit of the site by a group of senior officers to adjudge the suitability of the selection of the site based on the above observations. Representative of MoTA may also be invited on the date of site visit.

- 3.2 Mizoram: Representative of Govt. of Mizoram informed the Committee as follows:
- 1. The museum will be located at Mualngo, Kelsih area for which land is available.

- 2. The proposed museum will be named after Ropuiliani who was a personality of exceptional abilities and whose immense love for her people and her indomitable spirit to fight against the British repression was legendary. She died in a British Jail at Chittagong on January 3, 1895.
- 3. The proposed Museum will be a Resource Centre for providing information on tribal culture and tradition, to which all the resident population will flock, where all classes will learn lessons of history, and see for themselves the struggles and contribution made by Ropuiliani and other tribal freedom-fighters.

3.2.1 The Committee observed as under:

- 1. Expert Member appreciated the improvement made by the State Government with regard to progress of works.
- 2. Expert Member expressed satisfaction with the overall design of the project and engagement of expert Museologist for designing the Museum structure in sync with the story line.
- 3. To develop more area along the slope adjoining the museum site for trails.
- 4. Narrative reliefs may be incorporated instead of conventional statues of the 13 freedom fighters.
- 5. Local languages may be prominently used in the form of descriptions and inscriptions in the museum and tourism trails.
- 6. Services of local artists & craftsmen be prominently utilised for reliefs, display items, etc.
- 7. It was advised for maximum use of natural light in all the museum display areas as the exhibits are not usually sensitive to light and will make the experience better.
- 8. To make variation in sizes for the Traditional Huts proposed in the architectural design of the Museum.

3.2.2 Decision of NLC

The State Government may firm up the architectural design along with story line and finalize DPR of the project specifically with reference to the design parameters being suggested for the structure. State Government may seek balance sanctioned funds from MoTA with the DPR.

3.3 Andhra Pradesh: The Mission Director explained that the project location, architectural design along with story line has already been worked out. They presented two options of architectural designs i.e., 'Bow model Iconic building design' and the other 'traditional habitat model building'.

3.3.1 The Committee observed as under:

- Since the Museum should have tourist perspective and as the land is also plain, the bow type
 iconic building (Option I) may be suitable rather than Option 2 i.e, traditional type habitat
 model'. However it was further suggested that local tribal architecture shall be part of interior
 designs and ambiances.
- 2. It was also suggested that while using technological civilization, due care should be taken not to dominate the ecological civilization.
- 3. It shall be ensured that local classification is maintained, nuance / sounds of the local language, music shall be protected as well as various traditional management practices of the tribal areas

- such as classification of soils, water management, forest management, tribal ecological perception shall also be taken care of.
- 4. It was advised for maximum use of natural light in all the museum display areas as the exhibits are not usually sensitive to light and will make the experience better.
- 5. The display system should move away from dioramas and explore more options for enhancing the experience of the visitors.
- 6. The Landscape should be developed to create trails and continue the experience of the museum to the outdoors.
- 7. It was suggested that theme and Story line for other freedom fight movement in the state as well as neighbouring states such as Telangana, Chhattisgarh etc. be explored through research by engaging expert resource persons with anthropological background and the study report be furnished to MoTA latest by 30th April, 2020.
- 8. 10% of the MoTA's sanctioned budget can be utilised for developing the story line and theme through research. This aspect is very important and exclusive expert team shall be deployed for developing the story line and themes of freedom movements.
- 9. Since the Museum is to showcase the struggles of the freedom fighters with the support of Ministry in line with the Hon'ble Prime Minister's vision, the same may be taken up as a State project rather than Tribal Welfare Department Project. Accordingly, Departments of Tourism, Culture, Textiles, Environment & Forest and Infrastructural Departments may be taken on board for holistic development of the project site and ensuring development of eco-tourism in the vicinity as well as footfall in the museum.
- 10. Since the execution is already delayed, State to take immediate steps for obtaining sanction from the Govt. followed by floating of tenders for finalisation of the Executing Agency. Completion of civil works as well as other related works including procurement of showcase material, interior decorations, tribal habitats etc. shall be taken up simultaneously in order to ensure that the completion of the Museum in all respects is achieved by March, 2021.
- 11. The State representative was advised to avail professional guidance of knowledge partner (PMC) during the execution of the entire project to ensure adherence to the timelines.

3.3.2 Decision of NLC

The Committee approved for release of remaining balance funds i.e. Rs. 7.5 crore to the State Government of Andhra Pradesh during 2020-21 for completion of the project. The State has to appraise the progress to MoTA on monthly basis.

3.4. Jharkhand: Representative of State Govt. informed the Committee that construction work of the sanctioned Museum is almost complete. Share of fund committed by MoTA to the tune of Rs.25.00 Crore has already been received by them. The Museum will be ready for inauguration within 2-4 months. It was proposed by the representative of the State to consider inauguration date on 9th June 2020, that date being the Shaheed Diwas of Birsa Munda.

3.4.1 The Committee observed as under:

1. Showcase of prominent leaders of various tribes of Jharkhand be decorated attractively with local essence. Focus on involvement of local artisans and crafts in the design of exhibits and incorporation of local music/ language wherever possible be ensured.

- The museum should be appropriately displaying linkages with Philosophical parameters of Millenium Movements- besides Birsa Munda.
- To document work in progress and making of the museum on site as an audio-visual documentary / film.
- Documentation of locations of importance / actual sites in Chhota Nagpur where important events occurred in the revolt.
- Storing the output of workshops being conducted with local artists by TRI for the museum and display it in a temporary exhibition which changes from time to time. To create a repertoire of stories.

3.4.2 Decision of NLC

The Committee expressed no objection to the proposed date of inauguration of the Museum on 9th June 2020, that day being the Shaheed Diwas of Birsa Munda. Firmed up proposal for 2nd phase of the project may be submitted to MoTA.

3.5 Madhya Pradesh: The representative of the Madhya Pradesh informed that story line and architectural design are being finalized.

3.5.1 The Committee observed as under:

- 1. Since the Museum is to showcase the struggles of the freedom fighters with the support of Ministry in line with the Hon'ble Prime Minister's vision, the same may be taken up as a State project rather than Tribal Welfare Department Project. Accordingly, Departments of Tourism, Culture, Textiles, Environment & Forest and Infrastructural Departments may be taken on board for holistic development of the project site and ensuing development of ecotourism in the vicinity as well as footfall in the museum.
- 2. It was reiterated to make a tribal freedom fighter trail. History with pre-history should be linked. It may be considered to link Deogarh Quila with Museum for development of trail tourism. The story line be event based and issue based. Prominent tribal movements be included. The design and architecture should be such that it narrates the story line with proper infusion of technology. Local expert and artist should be engaged in this curation and storytelling part.
- 3. It was advised to organize a workshop-cum-consultation in the State to engage experts and local artists for comprehensive discussion. Secretary (TA) and Expert Member may be invited in the consultation.
- 4. **Other States:** The representatives from the following States where Tribal Freedom Figthers' Museum has been sanctioned remained absent:
