Subject: Special Central Assistance for Tribal Sub-Plan (SCA to TSP) during 2012-13 to the State of Madhya Pradesh - sanction of 2<sup>nd</sup> & Final installment (General).

Sir,

In continuation to this Ministry's sanction letter of even no. dated 27.06.2012, I am directed to convey the sanction of the President of India to the release of an amount of Rs. 79,48,56,000/- (Rupees Seventy Nine Crore Forty Eight Lakh Fifty Six Thousand only) as 2<sup>nd</sup> & final installment of grant-in-aid (General) to the Government of Madhya Pradesh towards SCA to TSP for the year 2012-13. The conditions/terms indicated in the sanction letter dated 27.06.2012 would *mutatis-mutandis* apply to the State Government for all releases under SCA to TSP. The funds are to be utilized for activities relating to employment-cum-Income generation activities as below (vide State Government letter No./SCA/161/1205 dated 06.06.2012): No UC is due for rendition up to 2010-11.
