Subject: Grants-in-aid to State Government of **Tripura** under the Scheme of **Upgradation of Merit of ST Students** for the year 2012-13.

Sir

I am directed to refer the proposal of State Government of **Tripura**, Tribal Welfare Department vide their letter No. F.14-9/TW/Upgradation/Coaching/2012-13/10984-85 dated 12/07/2012 on the above subject.


2. Sanction of the President of India is hereby conveyed to release an amount of **Rs. 3,12,000/- (Rupees Three lakh twelve thousand only)** to the State Government of Tripura for **16** (fresh) ST students under the Scheme of Upgradation of Merit of ST Students for the year 2012-13. The details of the grant calculated for 16 students for 10 months as per norms of the scheme are as under:-

3. An amount of Rs. 3,12,000/- has been released to the State Govt. of under the Scheme during 2011-12. The said amount was fully utilized by the state Government; nothing is pending unspent with them. No UC is due for rendition.

4. The aforesaid amount of Grants-in-aid will be subject to re-adjustment in due course on the basis of the audited figures of the amount actually disbursed by the State Government towards payment of the authorized scheme of Upgradation of Merit of ST Students for the year 2012-13.
