Sir,

In continuation to this Ministry's sanction letter of even no. dated 31.08.2012, I am directed to convey the sanction of the President of India to the release of an amount of Rs 18,52,00,000/- (Rupees Eighteen crore fifty two lakh only) as second installment of grant-in-aid to the Government of Gujarat towards SCA to TSP for the year 2012-13. The conditions/terms indicated in the sanction letter dated 31.08.2012 would *mutis-mutandis* apply to the State Government for all releases under SCA to TSP. 


