In continuation to this Ministry's sanction letter of even no. dated 28.09.2012, I am directed to convey the sanction of the President of India to the release of an amount of Rs 22,73,00,000/- (Rupees twenty two crore seventy three lakh only) as 2<sup>nd</sup> installment of grant-in-aid (General) to the Government of Jharkhand towards SCA to TSP for the year 2012-13. The conditions/terms indicated in the sanction letter dated 28.09.2012 would *mutis-mutandis* apply to the State Government for all releases under SCA to TSP.

You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of Jharkhand in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.

5. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance Division vide their Diary No. 849/JS&FA/13 dated 04.02.2013.
