2. Sanction of the President of India is hereby convey to release an amount of Rs 28,35,28000/- (Rs. Twenty Eight Crore Thirty Five Lakh Twenty Eight Thousand only) to the State Government of Gujarat as 1st installment under the Scheme of Pre-Matric Scholarship for ST students for the year 2013-14 to **Government of Gujarat** as 1st instalment (Ad-hoc grants) under the Centrally Sponsored Scheme of Pre-Matric Scholarship for ST students studying in Classes IX&X for the year 2013-14. The details of anticipated expenditure are given below:-
