Subject: Release of Grant under 1st proviso to Article 275(1) of the Constitution during 2013-14 to the State Government of Odisha for Innovative Projects-Grant-in-aid General.

Sir,

In continuation of this Ministry's sanction letter of even No. dated 5th June, 2013, I am directed to refer to the subject mentioned above and to convey the sanction of the President to the non-recurring grants-in-aid amounting to **Rs. 1395.00 lakh** under Article 275 (1) of the Constitution of India and to the release of **Rs. 1395.00 lakh (Rupees thirteen crore ninety five lakh only)** as 3rd installment to the State Government of Odisha, towards Grant-in-aid-General (other than capital assets), as payment of Central Assistance during 2013-14 for providing services of Artificial Insemination and Veterinary First Aid to Cows and Buffaloes by setting up of 770 ILD Centers in the Tribal Areas of 13 Districts of Odisha namely, Koraput, Malkangiri, Nawrangpur, Sundergarh, Mayurbhanj, Keonjhar, Boudh, Balasore, Kalahandi, Ganjam, Rayagada, Bargarh and Nuapada at a total cost of Rs.108.06 crore for a period of five years, as an innovative project, as recommended by the State Government of Odisha vide their letter No. 18684/TD-I-TSP-75/2010/SSD dated 07.05.2010 and No. 24646/TD/-I-TSP-75/2010/SSD dated 10.06.2010, to be implemented by J.K. Trust-Gram Vikas Yojana, Gurgaon(Haryana)

2. It is also subject to the condition that the Integrated Live-Stock Development must not be a stand-alone project and backward linkages (fodder, deworming, society farming, clean milk production) and forward linkages (Chilling, association with milk unions/ federations) must be ensured by the Implementing agency by having tie-ups with local milk unions to make this a successful economic activity.

3. No UC due is due for rendition.

4. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Odisha in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.

5. The expenditure is debitable to the :

6. The entire assistance is subject to adjustment on the basis of the audited figures of expenditure for the State Annual Plan 2013-14.

7. The State Government will implement the projects within the amount released by the Ministry during 2012-13 and keeping in view spirit of the guideline laid down on Grants under Article 275(1) of the Constitution vide its letter No. 14011/9/2001-SG&C dated 2-7-2002 & D.O. letter No. 14020/2/2008-SG-1 dated 30.01.2008 and other instructions issued from time to time.

8. The State Government is to transfer fund immediately within 30 days to the project implementing agencies and a copy of the fund transfer order may also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in a transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.

9. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry within 12 months of the closure of the financial year by the State Government as per provisions of GFR.

10. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their Diary No. 2521/JS&FA/2014 dated 15.02.2014.
