Subject: Release of Grant under 1st proviso to Article 275(1) of the Constitution during 2013-14 to the State Government of Himachal Pradesh – 2nd and final installment (General Grant-Recurring).

Sir,

In continuation to this Ministry's sanction letter of even no. dated 23.05.2013, I am directed to refer to the subject mentioned above and to convey the sanction of the President to the grants-in-aid (recurring) and to release **₹21,48,250.00 (Rupees twenty one lakh forty eight thousand two hundred fifty only)**, as **2nd and final installment** to the government of **Himachal Pradesh** under Article 275(1) of the Constitution the year 2013-14 towards General Grant (**Recurring**). The conditions/terms indicated in the sanction letter dated 23.05.2013 would *mutis-mutandis* apply to the State Government for all releases under Article 275(1) of the Constitution for taking up the activity "recurring grant for EMRS at Nichar for 186 student" as detailed by the State Government in the letter No. TBD.F(TDM)5-32/2007-IV dated 23.04.2013.

2. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of **Himachal Pradesh** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.

3. The expenditure is debitable to the :

- Major Head '3601' - Grants-in-aid to State Governments,
- Sub-major Head 02 - Grants for State Plan Schemes,
- Minor Head 796 - Tribal Area Sub-Plan
 - 01 - Welfare of Scheduled Tribes – Grants under Proviso to Article 275 (1) of the Constitution.
 - 02 - Scheme under Proviso to Article 275(1) of the



Constitution (Charged)
01.02.31 - Grants in-aid - General (Charged)
Demand No. - 95 for 2013-14 of the Ministry of Tribal Affairs

4. The entire assistance is subject to adjustment on the basis of the audited figures of expenditure for the State Annual Plan 2013-14.
5. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry as per provision of GFRs.
6. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their **Diary No. 628/JS&FA/2014 dated 14.03.2014**.
7. Certified that this sanction has been noted at **S. No. 81** in the register of grants.


