**Subject: Release of Grant under 1<sup>st</sup> proviso to Article 275(1) of the Constitution during 2013-14 to the State Government of Mizoram- sanction of 2<sup>nd</sup> and last installment (General Grant-Recurring).**

Sir,

In continuation to this Ministry's sanction letter of even no. dated 04.07.2013, I am directed to refer to the subject mentioned above and to convey the sanction of the President to the grants-in-aid (recurring) amounting to the release of **Rs.2,83,40,250.00 (Rupees two crore eighty three lakh forty thousand two hundred fifty only)** to the State Government of **Mizoram** for 2013-14, towards General grant as 2<sup>nd</sup> installment to the government of **Mizoram** under Article 275(1) of the Constitution for the year 2013-14. The conditions/terms indicated in the sanction letter dated 04.07.2013 would *mutis-mutandis* apply to the State Government for all releases under Article 275(1) of the Constitution.
