**Subject: Release of Grant under 1<sup>st</sup> proviso to Article 275(1) of the Constitution during 2013-14 to the State Government of West Bengal- 2<sup>nd</sup> installment (General Grant-recurring).**

Sir,

In continuation to this Ministry's sanction letter of even no. dated 07.05.2013, I am directed to convey the sanction of the President of India to the release of an amount of **₹15,25,98,000.00 (Rupees fifteen crore twenty five lakh ninety eight thousand only)** as **2<sup>nd</sup> installment** to the government of **West Bengal** under Article 275(1) of the Constitution the year 2013-14 towards General Grant. The conditions/terms indicated in the sanction letter dated 07.05.2013 would *mutis-mutandis* apply to the State Government for all releases under under Article 275(1) of the Constitution. The funds are to be utilized for the activities conveyed by the state government vide their letter No. BCW/6S(MC)-24, dated 11.04.2013 as mentioned below:-

3. The expenditure is debitable to the :




