2. Sanction of the President of India is hereby conveyed to release an amount of **Rs.6,78,75,000/- (Rs. Six crore, seventy eighty lakh, seventy five thousand only)** to Government of Tripura as full & final under the Scheme of Pre-Matric Scholarship for ST students studying in Classes IX&X during the year 2014-15. 
