
**Subject:-** Release of 1<sup>st</sup> instalment of funds under the Central Sector 'Scheme of Grant-in-aid to Tribal Research Institutes' to Tribal Research & Development Institute, Govt. of Madhya Pradesh, Bhopal for the year 2014-2015-reg

Sir,

In supersession of this Ministry's sanction letter of even no. dated 25<sup>th</sup> November, 2014, I am directed to convey the sanction of the President of India for an amount of Rs. 3, 15, 00,000/- (Rupees three crore fifteen lakh only) and to the release of Rs.66.00 lakh (Rupees sixty six lakh only) as part of 1<sup>st</sup> instalment for 2014-15 towards Grants-in-aid to the State Government of Madhya Pradesh for Tribal Research & Development Institute, Bhopal under the 'Scheme of Grant-in-aid to Tribal Research Institutes.

2. Out of the total sanctioned grant-in-aid of Rs.3.15 crore for the annual activities of the Institute for the year 2014-15, 50% of the grant i.e.Rs.1.575 crore will be released during 2014-15 and balance will be released during 2015-16. Remaining sanctioned grant for the current financial year 2014-15 will be released after the funds are made available at RE level. 4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.


5. The assets created, facilities developed and activities undertaken through the grant released by this Ministry shall be voluntarily disclosed before the Gram Sabha concerned.

8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure




