Subject: Payment of non-recurring grant-in-aid to State Govt. of Tripura towards 3rd instalment for completion of construction of 10 Hostels for ST students (7 girls & 3 boys) under the Scheme of "Hostels for ST Girls and Boys" during the current financial year 2014-2015.

Sir,

I am directed to refer to State Government of Tripura's letter No.F-22-1/TW/PLG/ENGG/2013-14/14,688-90 dated 24th October, 2014 and convey the sanction of the President of India to release grant-in-aid of Rs.15,39,71,189/- (Rupees Fifteen Crore Thirty Nine Lakh Seventy One Thousand One Hundred Eighty Nine only) towards 3rd instalment for construction of 10 Hostels for ST students (7 girls & 3 boys) to State Govt. of Tripura under the Centrally Sponsored Scheme of "Hostels for ST Girls and Boys". The GIA is for creation of Capital Assets. The details of grant-in-aid and location of hostels etc. is given at Annexure.

2. Certified that this sanction has been noted at S. No. _____ in Register of grants. At present no UCs are due and pending from the State Govt. in respect of this proposal.
3. The expenditure is debitable to Demand No. 97 -Ministry of Tribal Affairs, Major Head: 3601, "Grants-in-aid to State Governments"; 02- Grants for State Plan schemes (Sub Major Head), Minor Head: 796 Tribal Area Sub Plan, 08 -Umbrella Scheme for Education of ST Children 08.00.35-Grants for creation of capital assets (VOTED) for 2014-15.
4. Arrangements may be made to credit this amount to the State Govt. of Tripura in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2(45)/76-Spl.Cell dated 30-8-1976 as modified vide O.M. of even number dated 16-9-1976 under intimation to this Ministry.
5. Funds allocated for the scheme shall not be diverted to any other programme without the prior approval of the Govt. of India.
6. Any unspent amount shall not be carried forward for expenditure and it should be surrendered to the Central Government as per instructions contained in the Department of Expenditure, Ministry of Finance O.M. No. G-26305/1/77-MFCGA dated 4th June 1977.
7. Boys' and Girls' hostels shall be constructed at the place identified. State Govt. shall not change the location without prior approval of the Ministry.
8. The State Govt. shall furnish a certificate stating that the schemes have been accepted by the State Finance Department for implementation during the current financial year according to the procedure and pattern of central assistance prescribed by the Planning Commission for funding the Centrally Sponsored Schemes to this Ministry.
9. The State Govt. shall furnish physical progress report on the implementation of the Scheme to this Ministry every quarter.
10. Due to delay in taking up the construction activities, there may be cost overruns/escalations. Such overruns/escalations, if any, shall be met by the State Government from their own resources.

11. The land for the hostels will be provided by the State Govt. free of cost, on their own and the cost of land will not be included in the estimated cost of construction of these hostels.
12. The relevant cost of construction may be as per the approved rates of CPWD/State PWD.
13. The Utilization Certificate shall be submitted within 12 months of the closure of the financial year and quarterly progress report in terms of physical and financial shall be submitted to this Ministry.
14. As per the norms of the Schemes these hostels should be completed within a stipulated time frame of 2 years, as per the provisions of the revised scheme. Other norms of the revised scheme may strictly be followed.
15. The grantee organization shall voluntarily disclose the assets created, facilities developed and activity undertaken through this grant before the Gram Sabha concerned and also submit an undertaking/certificate in this regard to this Ministry.
16. This issues with the concurrence of Finance Division vide their Dy.No.1489/JS & FA/2015 dated 25.02.2015.
