In continuation to this Ministry's sanction letter of even nos. dated 19.06.2014 and 29.12.2014. I am directed to convey the sanction of the President of India for release of an amount of Rs.2,00,34,000/- (Rupees Two Crore Thirty Four Thousand Only), as 3rd installment to the Government of Nagaland under Article 275 (1) of the Constitution of India for the year 2014-15 towards General Grant (recurring)to carry out the following activities as detailed by the State Government in the letter No. PLN-260/2014 dated 17.12.2014 as under:

6. The State Government is to transfer fund immediately within 30 days to the project implementing agencies and a copy of the fund transfer order may also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in a transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.

7. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry within 12 months of the closure of the financial year by the State Government.

8. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their No.4248/JS&FA/2015 dated 17.02.2015.
