Subject: Release of Grants under Vanbandhu Kalyan Yojana (VKY) during 2014-15 to the State of Chhattisgarh - 2nd installment.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs.2,50,00,000/- (Rupees Two Crore Fifty Lakh only), as 2nd installment to the Government of Chattisgarh under Vanbandhu Kalyan Yojana (VKY) for the year 2014-15 to carry out the activities finalized with reference to the presentation made by the State in the meeting held at Shastri Bhawan on 20.01.2015 and as recorded in the proceedings of the meeting. The Activities to be executed in the Kondagaon Block of the State under VKY by the State of Chhattisgarh is as under:

2. The sanction of Rs. 10.00 Crore against above mentioned activities should be carried out while keeping following observations in mind during the course of implementation of the programmes:

- ✓ Attention to be given to raise the level of literacy.
- ✓ Make arrangement for science maths teachers in the schools.
- ✓ Explore using SATCOM technology for meeting education requirements.
- ✓ Focus on local employment.
- ✓ Adopt good practices for livelihoods and forest produces.
- ✓ Promote black pepper cultivation.
- ✓ Skill development in modern trades fetching respectable jobs.
- ✓ Establishing processing plants.
- ✓ More focus on traditional crop promotion and Dokra art.
- ✓ Training on Athletics (Archery & Kabbadi). Explore convergence with RKY.
- ✓ Due focus should be given on nutritional food intake for tribal families by providing facilities for backyard poultry, kitchen garden, diary development and other income generation activities.
- ✓ Focus to be given on vocational training centres providing employments with adequate handholding.
- ✓ Focus on paramedic training to improve health services in the locality.
- ✓ Convergence with other flagship programmes to be resorted to.
- ✓ Budget to be bifurcated with clear indication on State TSP, flagship programmes and budget required from Ministry of Tribal Affairs.


3. You may please transfer the amount immediately to the Government of Chhattisgarh and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of Chhattisgarh in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.

4. No UC is due for rendition.

5. The State Government is required to take action to transfer the funds received to respective ITDPs/ agencies. Progress Reports of the activities to be undertaken under VKY should be furnished to the Ministry on quarterly basis. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry within 12 months as per provisions of GFR.

6. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc.

7. The sanction is subject to adherence of above stipulations and other provisions to be issued in this regards from time to time. The sanction is also subject to final adjustment on the basis of audited figures of expenditure.
