Subject: Release of Grants under Vanbandhu Kalyan Yojana (VKY) during 2014-15 to the State of Maharashtra - 2nd installment.


Sir,



- ✓ Focus on Floriculture and mango cultivation.
- ✓ Training to teachers.
- ✓ Convergence of different programmes and schemes.
- ✓ Under health initiatives, Impact India Foundation to be consulted.
- ✓ Repairing of houses would not be supported from VKY.
- ✓ Distribution of Solar light not to be supported from VKY fund.
- ✓ Promotion of Culture, songs, arts to be supported.
- ✓ Government buildings to be used for Museum to display tribal culture.
- ✓ FRA implementation to be given priority.
- ✓ 100% immunization of pregnant mothers and students.

3. You may please transfer the amount immediately to the Government of **Maharashtra** and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of **Maharashtra** in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.

Progress Reports of the activities to be undertaken under VKY should be furnished to the Ministry on quarterly basis. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry within 12 months as per provisions of GFR.
6. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc.
7. The sanction is subject to adherence of above stipulations and other provisions to be issued in this regards from time to time. The sanction is also subject to final adjustment on the basis of audited figures of expenditure.
