2. The sanction of Rs. 10.00 Crore against above mentioned activities should be carried out while keeping following observations in mind during the course of implementation of the programmes:

- ✓ Focus on local employment.
- ✓ Adopt good practices for livelihoods and forest produces.
- ✓ Skill development in modern trades fetching respectable jobs.
- ✓ Establishing processing plants.
- ✓ More focus on traditional crop promotion.
- ✓ Training on Athletics (Archery & Kabbadi).
- ✓ Due focus should be given on nutritional food intake for tribal families by providing facilities for backyard poultry, kitchen garden, diary development and other income generation activities.
- ✓ Focus to be given on vocational training centres providing employments with adequate handholding.
- ✓ Convergence with other flagship programmes to be resorted to.
- ✓ Budget to be bifurcated with clear indication on State TSP, flagship programmes and budget required from Ministry of Tribal Affairs.
- ✓ Promotion of Culture, songs, arts to be supported.
- ✓ For Staff quarter and PHCs, NRHM funds to be used.
- ✓ Indira Awas Yojana to be explored for extra allocation given to Particularly Vulnerable Tribal Groups.
- ✓ Irrigation activities to be undertaken to promote traditional crops.
- ✓ Explore opportunities for horticulture.
- ✓ Residential schools to be supported.

3. You may please transfer the amount immediately to the Government of **Madhya Pradesh** and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of **Madhya Pradesh** in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. Dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.

4. No UC is due for rendition.

5. The State Government is required to take action to transfer the funds received to respective ITDPs/ agencies. Progress Reports of the activities to be undertaken under VKY should be furnished to the Ministry on quarterly basis. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry within 12 months as per provisions of GFR.
