
Subject: Release of Grant under Special Central Assistance to Tribal Sub-Plan (SCA to TSP) during 2014-15 to the State Government of Gujarat- 4th Installment (Additional).

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.11,84,24,000/- (Rupees Eleven Crore Eighty Four Lakh Twenty Four Thousand Only)**, as 4th installment to the Government of Gujarat under Special Central Assistance to Tribal Sub-Plan for the year 2014-15 to carry out the following activities as detailed by the State Government in the letter No.TAP/102014/640/GH dated 17.03.2015

Integrated Dairy Development Project	1184.24	"The dairy farms should be uncounted to farm cooperatives. The co-operatives have to be linked to District/Regional co-operatives for processing and marketing. The local variety of cows should be imposed in terms of milk production through dewarming, immunization, growing green fodder like Napier grass, and cleanliness. Testing of milk, training of farmers, daily collection of milk should be other aspects of sustainable dairy development. Local farmers should also be trained for A.I. for improvement of breed. Supply of milk cows from outside should not be encouraged through Government subsidy

3. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of **Gujarat** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.


4. The expenditure to the tune of **Rs. 11,84,24,000/- (Rupees Eleven Crore Eighty Four Lakh Twenty Four Thousand Only)** is debitible to the :

- Major Head '3601' - Grants-in-aid to State Governments
- Sub-major Head 02 - Grants for State Plan Schemes
- Minor Head 796 - Tribal Area Sub-Plan
 - 02 - Welfare of Scheduled Tribes – Grants under Proviso to Article 275 (1) of the Constitution.
 - 01 - Scheme under Tribal Sub-Plan (Charged)
 - 02.01.31 - Grants in-aid - General (Charged)
- Demand No. - 97 for 2014-15 of the Ministry of Tribal Affairs

5. Special Central Assistance to Tribal Sub-Plan (SCA to TSP) is an additive to the Tribal Sub-Plan of the State. SCA to TSP is meant for filling up of the critical gaps to cover employment-cum-income generation activities and the infrastructure incidental thereto of family based and these of the Self-Help Groups/community and thus, raise the socio-economic level of the Schedule Tribes. The funds are to be expended in accordance with the guidelines issued by the Ministry of Tribal Affairs from time to time.

6. The State Government is required to take action to transfer the funds received to respective ITDPs/ agencies. No part of the SCA should be released directly to any Department at the State level. However, transfer of funds to implementing departments/ agencies, if required, should be done through the ITDPs.

7. State Government is to ensure release of funds to ITDPs/ implementing agencies within one month of receipt of funds. Progress Reports of the SCA to TSP may be furnished to the Ministry in the prescribed format already circulated

along with the guidelines. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry within 12 months as per provisions of GFR.

8. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc. In case of construction of infrastructure facilities, norms and Schedule of Rates (SOR) fixed by the State Government should be followed.

9. The sanction is subject to final adjustment on the basis of audited figures of expenditure.

10. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their No.3713/JS&FA/2015 dated 19.03.2015.

11. Certified that this sanction has been noted at S. No. 26. in the register of grants.
