4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
5. The assets created, facilities developed and activities undertaken through the grant released by this Ministry shall be voluntarily disclosed before the Gram Sabha concerned.
6. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the KSTRI/State Govt.




