

5. The assets created, facilities developed and activities undertaken through the grant released by this Ministry shall be voluntarily disclosed before the Gram Sabha concerned.
6. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the MLVTRTI/State Govt.


8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.


