In continuation to this Ministry's sanction letter of even no. dated 03.12.2014 and 23.02.2015, I am directed to convey the sanction of the President of India for the release of Rs.78.75 lakh (Rupees seventy eight lakh seventy five thousand only) as 3rd instalment of 2014-15 towards Grants-in-aid to the State Government of Madhya Pradesh for Tribal Research & Development Institute, Bhopal under the 'Scheme of Grant-in-aid to Tribal Research Institutes.

2. Out of the total sanctioned grant-in-aid of Rs.3.15 crore for the annual activities of the Institute for the year 2014-15, 50% of the grant i.e.Rs.1.575 crore was released during 2014-15 and balance was to be released during 2015-16. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Madhya Pradesh in accordance with procedure laid down in the Ministry of Finance's O.M No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by O.M of even number dated 16.9.1976.
3. The above mentioned amount is sanctioned under the scheme "Research Information & Mass Education, Tribal Festivals and others (Grant -in-aid to Tribal Research Institutes) during 2015-16.
4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
5. The assets created, facilities developed and activities undertaken through the grant released by this Ministry shall be voluntarily disclosed before the Gram Sabha concerned.
6. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the TRTI/State Govt.
7. No UC is due for rendition. Utilization Certificate in respect of grant being released now should be submitted in forms GFR-19 A in terms of Rule 212 of GFR 2005.
8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure
9. The expenditure is debitable to the Major Head "3601", Grants-in-aid to State Governments(Major Head), 03 Grants for Central Plan Scheme(Sub Major Head), 796 Tribal Area Sub Plan (Minor Head), 13 Welfare of Scheduled Tribes-Education-Research Information & Mass Education , Tribal Festivals and Others, 01- Research Information & Mass Education, Tribal Festivals & Others, 13.01.31- Grants-in-aid General (Charged) under Demand No. 98 of the Ministry of Tribal Affairs for 2015-16 (Plan).
10. The sanction is issued in exercise of delegated powers in consultation with the Integrated Finance Division, Ministry of Tribal Affairs vide their FTS Dy No. 3893/JS&FA/15 dated 16.06.2015.
