3. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
4. The assets created, facilities developed and activities undertaken through the grant released by this Ministry shall be voluntarily disclosed before the Gram Sabha concerned.
5. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the TRI/State Govt.
6. No UC is due for rendition. Utilization Certificate in respect of grant being released now should be submitted in forms GFR-19 A in terms of Rule 212 of GFR 2005.

The expenditure is debitible to the Major Head "3601", Grants-in-aid to State Governments(Major Head), 03 Grants for Central Plan Scheme(Sub Major Head), 796 Tribal Area Sub Plan (Minor Head), 13 -Welfare of Scheduled Tribes-Education-Research Information & Mass Education , Tribal Festivals and Others, 01- Research Information & Mass Education, Tribal Festivals & Others, 13.01.31- Grants-in-aid- General (charged) under Demand No. 98 of the Ministry of Tribal Affairs for 2015-16 (Plan)
