8. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Gujarat in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.

9. The grantee organization shall voluntary disclose the assets created, facilities developed and activity undertaken through this grant before the Gram Sabha concerned and also submit and undertaking/ certificate in this regard to this Ministry.

10. Scholarships are payable to the ST according to the Guidelines of the Scheme.


11. State Government has no authority to divert the funds for other purpose.


