I am directed to convey the sanction of the President of India for release of an amount of **Rs. 60,00,000/- ( Rupees Sixty Lakh only)** to the Government of Bihar as 2nd and final installment Grant for Capital Assets under **Vanbandhu Kalyan Yojana (VKY)** for the year 2015-16 to carry out the activities finalized with reference to the presentation made by the State in the meeting held at Shastri Bhawan on 24.09.2015 and as recorded in the proceedings of the meeting:-

2. The sanction of **Rs. 60,00,000/- ( Rupees Sixty Lakh only)** against above mentioned activities should be carried out while keeping in mind the observations of PAC as recorded in the minutes of the PAC meeting dated 24.09.2015.
3. You may please transfer the amount immediately to the Government of **Bihar** and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of **Bihar** in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to Programme Division of the Ministry.
4. No Grant was released during 2014-15.
5. The State Government is required to take action to transfer the funds received to respective ITDPs/ agencies. Progress Reports of the activities to be undertaken under VKY should be furnished to the Ministry on quarterly basis. Provisional utilization certificate in r/o General Grants may be furnished immediately after the end of the financial year 2015-16. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry within 12 months as per provisions of GFR.
6. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure and norms in vogue in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc.
7. The sanction is subject to adherence of above stipulations and other provisions to be issued in this regards from time to time. The sanction is also subject to final adjustment on the basis of audited figures of expenditure.
8. The expenditure is debitable to the:
  - Major Head '3601' - Grants-in-aid to State Governments
  - Sub-major Head 03 - Grants for Central Plan Schemes
  - Minor Head 796 - Tribal Area Sub-Plan
    - 08 - Welfare of Scheduled Tribes Education.
    - 07 - Van Bandhu Kalyan Yojana
    - 08.07.35 - Grants for creation of Capital Assets (Charged)
  - Demand No. - 98 or 2015-16 of the Ministry of Tribal Affairs
