5. No UC is due for rendition. Utilization Certificate in respect of grant being released now should be submitted in forms GFR-19 A in terms of Rule 212 of GFR 2005.

The expenditure is debitable to the Major Head "3601", Grants-in-aid to State Governments(Major Head), 03 Grants for Central Plan Scheme(Sub Major Head), 796 Tribal Area Sub Plan (Minor Head), 13 Welfare of Scheduled Tribes-Education-Research Information & Mass Education, Tribal Festivals and Others, 01- Research Information & Mass Education, Tribal Festivals & Others, 13.01.31- Grants-in-aid General (Charged) under Demand No. 98 of the Ministry of Tribal Affairs for 2015-16.(Plan).




