
Sir,

I am directed to convey the sanction of the President of India for release of an amount of **₹.6,46,80,000/- (Rupees Six Crore Forty Six Lakh Eighty Thousand Only)**, as final installment to the Government of Jharkhand towards final grant for creation of capital assets under Special Central Assistance to Tribal Sub-Plan (SCA to TSP) for the year 2015-16 for carrying out the following activities as approved by Project Appraisal Committee (PAC) in its meeting held on 21.04.2015 and State Govt's request vide letter No. 07/Article 275(1) of the Constitution of India.275(1)/05/2015/3727 dated 18.12.2015, is as under:-



7. The State Government will adhere to the instructions contained in the minutes of PAC meetings pertaining the State(s) concerned scrupulously. A copy of the projects implemented by the State Government is required to be sent to the Ministry. The State Government would ensure that:

i. construction component of the project is based on the schedule of rates of CPWD/PWD or any other scheduled of rates approved by a competent authority.

ii project(s) has the clearance of the State Government from the technical / financial / administrative angles.

8. The State Government is to transfer fund immediately within 30 days to the project implementing agencies and a copy of the fund transfer order may also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in a transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.

9. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry within 12 months of the closure of the financial year by the State Government.

10. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their No. 5798/JS&FA/2015 dated 22.03.2016.
