
Sir,

I am directed to convey the sanction of the President of India for an amount of Rs. **2500.00 Lakhs ( Rs. Twenty Five Crores only)** towards C/o of 14 ST boys hostels and C/o 14 ST Girls hostels in Residential schools run by Department of Welfare in TSP Districts and to release of an amount of **₹.25,00,00,000/- (Rupees Twenty Five Crore Only)** for creation of capital assets/non-recurring grant to the Government of Jharkhand as additional funds under Article 275(1) of the Constitution for the year 2015-16 with reference letter No. 07/Art 275(1) Pari/Pra/ 05/2015-899 dated 11.3.2016 to carry out the following activities as detailed below:-

You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of **Jharkhand** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.

5. The entire assistance is subject to adjustment on the basis of the audited figures of expenditure for the State Annual Plan 2015-16.

6. The State Government will implement the projects within the amount released by the Ministry during 2015-16 and keeping in view the spirit of the provisions contained under Operational Guidelines for formulation, implementation and monitoring of TSP and Article 275(1) funds, issued by Ministry of Tribal Affairs during March, 2014 and Revised Guidelines for Implementation of TSP issued by erstwhile Planning Commission during June 2014 and other relevant instructions issued from time to time.

7. The State Government will adhere to the instructions contained in the minutes of PAC meetings pertaining the State(s) concerned scrupulously. A copy of the projects implemented by the State Government is required to be sent to the Ministry. The State Government would ensure that:

i. construction component of the project is based on the schedule of rates of CPWD/PWD or any other scheduled of rates approved by a competent authority.

ii project(s) has the clearance of the State Government from the technical / financial / administrative angles.

8. The State Government is to transfer fund immediately within 30 days to the project implementing agencies and a copy of the fund transfer order may also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in a transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.

9. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be

furnished to the Ministry within 12 months of the closure of the financial year by the State Government.

10. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their No. 5347/JS&FA/2016 dated 23.3.2016
