**Subject: Release of funds during 2015-16 to the State Government of Nagaland under Article 275(1) of the Constitution as additional for creation of capital assets as 3<sup>rd</sup> instalment.**

I am directed to convey the sanction of the President of India for an amount of Rs. 1700.00 Lakhs towards (i) Integrated Community Based Fishery, Poultry and Piggery project at Rangmapani Village, District Kohima (ii) Skill Development and Training for Women Group at Mokokchung and (iii) Establishment of Modern Mechanical Workshop-cum-training Institute with attached hostels for trainees at Dimapur and to release of an amount of ₹.17,00,00,000/- (Rupees Seventeen Crore Only) for creation of capital assets/non-recurring grant to the Government of Nagaland as additional funds under Article 275(1) of the Constitution for the year 2015-16 with reference to Hon'ble Chief Minister of State Government letter dated 21.1.2016 and letter No. PLN-38/2015 dated 5.6.2015 to carry out the following activities as detailed below:-

5. The entire assistance is subject to adjustment on the basis of the audited figures of expenditure for the State Annual Plan 2015-16.

6. The State Government will implement the projects within the amount released by the Ministry during 2015-16 and keeping in view the spirit of the provisions contained under Operational Guidelines for formulation, implementation and monitoring of TSP and Article 275(1) funds, issued by Ministry of Tribal Affairs during March, 2014 and Revised Guidelines for implementation of TSP issued by erstwhile Planning Commission during June 2014 and other relevant instructions issued from time to time.

7. The State Government will adhere to the instructions contained in the minutes of PAC meetings pertaining the State(s) concerned scrupulously. A copy of the projects implemented by the State Government is required to be sent to the Ministry. The State Government would ensure that:

i. construction component of the project is based on the schedule of rates of CPWD/PWD or any other scheduled of rates approved by a competent authority.

ii project(s) has the clearance of the State Government from the technical / financial / administrative angles.

8. The State Government is to transfer fund immediately within 30 days to the project implementing agencies and a copy of the fund transfer order may also be sent to this Ministry. It may be ensured that the grants are used for the purpose for which they are sanctioned after following the due procedure in a transparent manner and obtaining all necessary clearances as required under the various Central/State Acts, Rules and Regulations etc.
