**ORDER**


Sanction of the President is hereby accorded for making payment of amount of Rs. 22,87,440/- (Twenty two lakh eighty seven thousands four hundred and forty only) as 1<sup>st</sup> instalment to Sports Authority of India, Jawaharlal Nehru Stadium for booking of venue for 26 days from 13<sup>th</sup> April to 8<sup>th</sup> May, 2016 in connection with the National Tribal Carnival 2016. The expenditure involved is in connection with the participation of guests from different States and events planned / approved for the National Tribal Carnival. The details of the expenditure sanction in favour of SAI, JNS are as under

2. Out of the total expenditure ceiling of Rs. 35,74,125/- (Rs. Thirty five lakh seventy four thousands one hundred and twenty five), it is proposed to make a payment of 64% of the total amount i.e. Rs. 22,87,440/- (Twenty two lakh eighty seven thousands four hundred and forty only) as 1<sup>st</sup> instalment for this purpose. The security amount of Rs. 2,25,000/- (Rs. Two lakh twenty five thousands only) is including in the gross booking amount of the venue and will be refunded by Sports Authority of India, Jawaharlal Nehru Stadium.

3. The Drawing and Disbursing Officer, Ministry of Tribal Affairs, is authorized to make payment for Rs. 22,87,440/- (Twenty two lakh eighty seven thousands four hundred and forty only) in favour of Secretary, Sports Authority of India, New Delhi. The payment may be made to their Andhra Bank Account no. 108510011000101, IFSC Code: ANDB0001085, MICR Code: 110011015 through ECS/RTGS/NEFT/CBS by PAO.

4. The expenditure is debitable to the Major Head "2225", Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities (Major Head), 02 Welfare of Scheduled tribes (Sub Major Head), 796 Tribal Area Sub Plan (Minor Head), 09 Welfare of Scheduled Tribes-other expenditure, 06-Research Information & Mass Education, Tribal Festival & Other 09.06.50 – Other Charges under Demand No. 98 of the Ministry of Tribal Affairs for 2015-16 (Plan).


- (a) GFR provisions are compiled with; &
