Subject: Payment of 2nd Instalment of Non-recurring grant-in-aid to State Govt. of Rajasthan for Construction of 13 Girls Hostels during 2015-16.

Sir,

I am directed to refer to letter No F7 (2)(17)/16/990 dated 14/03/2016 received from the State Government of Rajasthan and convey the sanction of the President of India to the recurring grant-in-aid of **₹3,56,31,500.00 (Rupees Three Crore Fifty Six Lakh Thirty One Thousand and Five Hundred Only)** towards 2nd instalment for Construction of 13 Girls Hostels during current financial year 2015-16. The GIA is for creation of Capital Assets. The details of grant-in-aid and location of hostels etc. is given at Annexure-I.

2. Certified that this sanction has been noted at S.No.53 in Register of grants. At present no UCs are due and pending from the State Govt. in respect of this proposal.


3. The expenditure is debitable to Demand No.98 - Ministry of Tribal Affairs, Major Head 3601. - Grant-in-aid to State Government, 02-Grants for State Plan Schemes (Sub-Major Head), 796-Tribal Areas Sub-Plan (Minor Head), 08-Umbrella Scheme for Education of ST Children, 08.00.35 - Grants for creation of capital assets (Charged) for the year 2015-16.

4. Arrangements may be made to credit this amount to the State Govt. of **Rajasthan** in accordance with the procedure laid down in the Ministry of Finance O.M. No.2(45)/76-Spl.Cell dated 30-08-1976 AS modified vide O.M. of even number dated 16-9-1976 under intimation to this Ministry.

5. Funds allocated for the scheme shall not be diverted to any other programme without the prior approval of the Govt. of India.


6. Any unspent amount shall not be carried forward for expenditure and it should be surrendered to the Central Government as per instructions contained in the Department of Expenditure, Ministry of Finance O.M. No.G-26305/1/77-MFCGA dated 4th June 1977.

7. The Girls Hostels shall be constructed at the place identified.

8. The State Govt. shall furnish a certificate stating that the schemes have been accepted by the State Finance Department for implementation during the current financial year according to the procedure and pattern of central assistance prescribed by the Planning Commission for funding the Centrally Sponsored Schemes to this Ministry.
9. The State Govt. shall furnish physical progress report on the implementation of the Scheme to this Ministry every quarter.
10. Due to delay in taking up the construction of activities, there may be cost overruns/escalations. Such overruns/escalations, if any, shall be met by the State Government from their own resource.
11. The relevant cost of construction may be as per the approved rates of CPWD/State PWD.
12. The Utilization Certificate shall be submitted within 12 months of the closure of the financial year 2015-16 and quarterly progress report in terms of physical and financial shall be submitted to this Ministry.
13. As per the norms of the Schemes these hostels should be completed within a stipulated time frame of 2 years, as per the provisions of the revised scheme. Other norms of the revised scheme may strictly be followed.
14. This issues with the concurrence of Finance Division vide their Dy.No.221/JS&FA/16 dated 31/03/2016.
