Sanatorium, District- Ranchi, Jharkhand on reimbursement basis during current financial year 2016-17 under the scheme of "Grants-in-aid to voluntary organizations working for the welfare of scheduled tribes".

Sir,

I am directed to refer to letter No. 7/NGO-03/2013-K-2794 dated 02.09.2015 from the Government of Jharkhand, Welfare Department on the subject mentioned above and to convey the sanction of the President of India and to release Grant-in-aid of **Rs.1,02,21,027/- (Rupees One Crore two lakh twenty one thousand twenty seven only)** towards **full & final instalment for the year 2015-16** on reimbursement of expenditure basis during the current financial year 2016-17 as per details of expenditure enclosed at Annexure-I, after adjusting unspent balance of Rs.1133993/-(Rupees Eleven Lakh Thirty Three Thousand Nine Hundred and Ninety Three only) to Ramakrishna Mission Tuberculosis Sanatorium, Village- Dungri, Block/Mandal- Namkum, PO- R.K. Sanatorium, District- Ranchi, Pin code-835221, Jharkhand for running & maintenance of ongoing project of **70-Bedded Hospital and Mobile Dispensary** at Village- Dungri, Block/Mandal- Namkum, on reimbursement basis during current financial year 2016-17. The last grant for the year 2014-15 amounting to Rs.13073900/- was released during 2014-15 on budget estimate basis vide Sanction Order No.22036/02/2011-NGO(vol. I) dated 18.3.2015 and Utilization certificate for the same has been submitted. No utilisation certificate is due for rendition. The grant-in-aid shall be subject to provisions of GFR-2005 and terms & conditions of scheme. The list of documents to be maintained as per GFR is indicated in Annexure-II.

2. Since the above grant has been sanctioned by way of reimbursement of expenditure already incurred on the basis of duly audited accounts, no UC is required in respect of grant in aid sanctioned for 2014-15 in terms of Note 1 of Rule No. 212(1) of GFR.

3. The accounts of all grantee Institutions/organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or organization is called to do so.
