Sub: Conservation-cum-development (CCD) Plan for Particularly Vulnerable Tribal Groups (PVTGs) of Jharkhand for 12<sup>th</sup> Five Year Plan under the Scheme of Development of Particularly Vulnerable Tribal Groups - Grant-in-Aid to the State Govt. of Jharkhand for the financial year 2016-17 thereof.

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs.4,04,00,000/- (Rupees Four Crores Four Lakhs only) as 2nd installment to the State Government of Jharkhand towards Grant-in-Aid (for creation of capital assets) under the Central Sector Scheme of "Development of Particularly Vulnerable Tribal Groups" for the year 2016-17 for the following activities:**

1.	Common facility Centre (for Asur, Birhor, Birajiya, Korwa savor, Parhaiya, mal Paharaia)	Rs.1400.00 Lakhs ( an amount of Rs.451.00 Lakhs has already been released as first installment to the State Government of Jharkhand vide this Ministry's sanction order dated 28.09.2016 under the Budget head creation of Capital assets under the scheme).Rest amount will be released after receiving proper Utilization certificate and Physical Progress Report of the last grant released)

2. Further, an amount of Rs.3,45,00,000/- (Rupees Three Crores Forty Five Lakhs Only) has already been released to the State Government of Jharkhand as Grant-in-aid (General) vide this Ministry's communication dated 28.09.2015 as ad-hoc Grant for the year 2016-17. Now, the activities approved for the activities as Grant-in-Aid (General) for the year 2016-17 are as under:-



1.	Income Generational Promotional Scheme (for Sauriya, Bahariya, Asur, Birhor, Korwa, Jajal, Parhaiya, Mal Paharaia, etc.)	Rs.200.00 Lakhs

4. Balance of approved amount will be released after receipt of proper Utilization Certificate towards recurring grant released during 2015-16 under the scheme.
5. The works/activities shall be taken up in accordance with an implementation schedule drawn by Scheduled Tribe & Scheduled Caste Development Department of the State and submitted to the Ministry.
6. The grant-in-aid shall be subject to provisions of GFR, 2005.
7. The Utilization Certificate for non-recurring and recurring grant will be submitted by the State Govt. to the Ministry as per Rule 212 of the GFR 205 in Form GFR-19-A.
8. The State Government shall ensure that there is no unspent balance out of this grant left with them at the end of current financial year. The Unspent balance, if any, will be surrendered to the Ministry of Tribal Affairs.
9. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and for the welfare of members of PVTGs only.
10. The financial assistance given to ITDPs/ITDAs and TRIs should be deemed to have been given to the State Government concerned and rules and regulation governing the grants-in-aid to States/UTs shall apply to them.
11. Physical and financial Progress in respect of activities to be undertaken in this regard shall be reported every quarter.
12. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Jharkhand in accordance with procedure laid down in the Ministry of Finance's OM No.2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to this Ministry.
13. The implementing agency shall allow the representative of this Ministry or the independent agency appointed by this Ministry or the State Government to inspect actual working of the scheme.
14. No UC is due for rendition.
15. The expenditure to the tune of Rs.4,04,00,000/- ( Rupees Four Crores Four Lakhs only) is debitabale to the
