
Sub: Release of grants to State Government of Maharashtra for carrying out activities of CCD Plan for the year 2016-17 under the Scheme of Development of Particularly Vulnerable Tribal Groups (PVTGs) – Grants-in-Aid (General).

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs.7,93,00,000/- (Rupees Five Crores Ninety Three Lakhs only) as 2nd installment to the State Government of Maharashtra towards Grant-in-Aid (General) under the Central Sector Scheme of “Development of Particularly Vulnerable Tribal Groups” for the year 2016-17 for the following activities:

1.	Integrated Agriculture Development Plan for PVTG beneficiaries from FRA	Rs.800.00 Lakhs
2.	Establishment of Backyard Poultry for PVTG families (400 Beneficiaries)	Rs.200.00 Lakhs
	Total	Rs.1000.00 Lakhs (out of which an amount of Rs.207.00 Lakhs has already been released as first installment vide this Ministry's communication of even number dated 28.09.2016)

- The grant in aid shall be subject to provisions of GER 2005
- The works/activities shall be taken up in accordance with an implementation schedule drawn by Tribal Development Department of the State and submitted to the Ministry.
- The Utilization Certificate for non-recurring and recurring grant will be submitted by the State Govt. to the Ministry as per Rule 212 of the GFR 2005 in Form GFR-19-A.
- The State Government shall ensure that there is no unspent balance out of this grant left with them at the end of current financial year. The Unspent balance, if any, will be surrendered to the Ministry of Tribal Affairs.

6. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and for the welfare of members of PTGs only.

7. The financial assistance given to ITDPs/ITDAs and TRIs should be deemed to have been given to the State Government concerned and rules and regulation governing the grants-in-aid to States/UTs shall apply to them.

9. Physical and financial Progress in respect of activities to be undertaken in this regard shall be reported every quarter.

10. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Maharashtra in accordance with procedure laid down in the Ministry of Finance's OM No.2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to this Ministry.

11. The implementing agency shall allow the representative of this Ministry or the independent agency appointed by this Ministry or the State Government to inspect actual working of the scheme.

12. No UC is due for rendition.

13. The expenditure to the tune of **Rs.7,93,00,000/- (Rupees Seven Crores Ninety Three Lakhs Only)** is debitible to the


