Subject: Grant-in-Aid towards full & final instalment for the year 2014-15 and 2015-16 to Pandey Siksha Samiti, Village- Bhamarha, P.O.-Deodaha, District- Satna, Madhya Pradesh as Recurring grant for running & maintenance of ongoing project of Educational Complex (Primary Level) for ST Girls at Village/PO- Barkachh, Block- Jaisinghnagar, District-Shahdol, Pin code-484774, Madhya Pradesh on reimbursement basis during current financial year 2016-17 under the scheme of "Strengthening Education among Scheduled Tribe (ST) Girls in Low Literacy Districts".

Sir,

I am directed to refer to letter no. F-10/03/2015/25-2 dated 26.12.2015 and No. F-10/03/2014/25-2 dt 18.03.2016 from the Government of Madhya Pradesh, Scheduled Tribes Welfare Department on the subject mentioned above and to convey the sanction of the President of India and to release Grant-in-aid of **Rs42,66,293/- (Rupees Forty Two Lakh Sixty Six Thousand Two Hundred Ninety Three only)** towards **full & final instalment for the year 2015-15 and 2015-16** on reimbursement of expenditure basis during the current financial year 2016-17 as per details of expenditure enclosed at Annexure-I, after adjusting unspent balance of Rs.NIL/- to Pandey Siksha Samiti, Village- Bhamarha, P.O.-Deodaha, District- Satna, Madhya Pradesh as Recurring grant for running & maintenance of ongoing project of Educational Complex (Primary Level) for ST Girls at Village/PO- Barkachh, Block- Jaisinghnagar, District-Shahdol, Pin code-484774, Madhya Pradesh. The last grant for the year 2012-13 amounting to Rs.21,56,000/- was released during 2013-14 vide Sanction Order 11036/27/97-NGO(TDC)(Pt.II) dated 22.02.2014 by way of reimbursement. Therefore, no utilization certificate is required in terms of Note 1 under the Rule 212(1) of the GFRs. No utilisation certificate is due for rendition. The grant-in-aid shall be subject to provisions of GFR-2005 and terms & conditions of scheme. The list of documents to be maintained as per GFR is indicated in Annexure-II.

2. Since the above grant has been sanctioned by way of reimbursement of expenditure already incurred on the basis of duly audited accounts, no UC is required in respect of grant in aid sanctioned for 2014-15 and 2015-16 in terms of Note 1 of Rule No. 212(1) of GFR.

3. The accounts of all grantee Institutions/organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or organization is called to do so.
