Sanction of the President of India is hereby conveyed to release an amount of **Rs.3,75,000/- (Rupees Three Lakh Seventy Five Thousand only)** to the UT Administration of **Daman & Diu** as 1st installment of recurring grant-in-aid (ad hoc grant) under the Scheme of Post-Matric Scholarship to the students belonging to STs for the year 2017-18.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debitable to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2017-18:-

5. Scholarships are payable to the ST according to the Guidelines of the Scheme. The UT Administration shall ensure that the Scholarship funds received from the Government of India/Ministry of Tribal Affairs are released directly to the beneficiaries electronically as laid down in Union Ministry of Finance's Office Memorandum No. I-11011/58/2013-DBT dated 27/08/2015.
