Sir,

Sanction of the President of India is hereby conveyed to release an amount of **Rs.10,60,00,000/- (Rupees Ten Crore Sixty Lakh only)** to the **State Government of Andhra Pradesh** as 1st installment of recurring grant-in-aid (ad hoc grant) under the Scheme of Post-Matric Scholarship to the students belonging to STs for the year 2017-18.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debit to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2017-18:-

7. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
