Sanction of the President of India is hereby conveyed to release an amount of **Rs.50,000/- (Rupees Fifty Thousand only)** to the UT Administration of Andaman & Nicobar Islands as 1st installment of recurring grant-in-aid (ad hoc grant) under the Scheme of Post-Matric Scholarship to the students belonging to STs for the year 2017-18.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

5. Scholarships are payable to the ST according to the Guidelines of the Scheme. The State Government shall ensure that the Scholarship funds received from the Government of India/Ministry of Tribal Affairs are released **(directly to the beneficiaries electronically as laid**

6. The amount will be drawn by the Union Territory of Andaman & Nicobar in accordance with the procedure laid down in the Ministry of Finance (Department of Expenditure) O.M. No.1(9)/7/86-CA/1099 dated 30-01-1976 and as modified vide OM of even number dated 16-09-1976 under intimation to this Ministry.
7. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
