Sub: Conservation-cum-development (CCD) Plan for Particularly Vulnerable Tribal Groups (PVTGs) of Andhra Pradesh for 12<sup>th</sup> Five Year Plan under the Scheme of Development of Particularly Vulnerable Tribal Groups - Grant-in-Aid to the State Govt. of Andhra Pradesh for the financial year 2016-17 thereof.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 2,57,00,000/- (Rs. Two Crores fifty Seven Lakhs only) as 1<sup>st</sup> instalment on ad-hoc basis to the State Government of Andhra Pradesh towards Grant-in-Aid (General) under the Central Sector Scheme of "Development of Particularly Vulnerable Tribal Groups" for the year 2016-17 for the activities under Annual Plan for 2016-17.

2. The actual expenditure would be incurred only after the Annual Plan of the concerned State is approved by the Project Appraisal Committee (PAC) of Ministry of Tribal Affairs.
3. The works/activities shall be taken up in accordance with an implementation schedule drawn by Scheduled Tribe & Scheduled Caste Development Department and submitted to the Ministry.
4. The grant-in-aid shall be subject to provisions of GFR, 2005.
5. The Utilization Certificate for non-recurring and recurring grant will be submitted by the State Govt. to the Ministry as per Rule 212 of the GFR 2005 in Form GFR-19-A.
6. The State Government shall ensure that there is no unspent balance out of this grant left with them at the end of current financial year. The Unspent balance, if any, will be surrendered to the Ministry of Tribal Affairs.
7. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and for the welfare of members of PVTGs only.

8. The financial assistance given to ITDPs/ITDAs and TRIs should be deemed to have been given to the State Government concerned and rules and regulation governing the grants-in-aid to States/UTs shall apply to them.
9. Physical and financial Progress in respect of activities to be undertaken in this regard shall be reported every quarter.
10. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Andhra Pradesh in accordance with procedure laid down in the Ministry of Finance's OM No,2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to this Ministry.
11. The implementing agency shall allow the representative of this Ministry or the independent agency appointed by this Ministry or the State Government to inspect actual working of the scheme.
12. No UC is due for rendition.
13. The expenditure to the tune of **Rs.2,57,00,000/- ( Rupees Two Crore Fifty Seven Lakhs Only)** is debitible to the


