4. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the TRCI/State Govt.
5. The Utilization Certificate in respect of grant being released should be submitted in forms GFR-12 C in terms of Rule 239 of GFR 2017.

The expenditure is debitable to the Major Head "3601", Grants-in-aid to State Governments 06 -Grants for Centrally Sponsored Scheme (Sub Major Head), 796 Tribal Area Sub Plan (Minor Head), 34 -Umbrella Programme for Development of Scheduled Tribes : Support to Tribal Institutions, 02- Support to Tribal Research Institutes. 34.02.31 - Grants-in-aid General (Charged) under Demand No. 96 of the Ministry of Tribal Affairs for the year 2017-18"
