2.. The works/activities shall be taken up in accordance with an implementation schedule drawn by Scheduled Tribe & Scheduled Caste Development Department of the State and submitted to the Ministry.

3. The grant-in-aid shall be subject to provisions of GFR, 2005.

4. The Utilization Certificate for non-recurring and recurring grant will be submitted by the State Govt. to the Ministry as per Rule 212 of the GFR 205 in Form GFR-19-A.

5. The State Government shall ensure that there is no unspent balance out of this grant left with them at the end of current financial year. The Unspent balance, if any, will be surrendered to the Ministry of Tribal Affairs.

8. Physical and financial Progress in respect of activities to be undertaken in this regard shall be reported every quarter.

9. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Jharkhand in accordance with procedure laid down in the Ministry of Finance's OM No.2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to this Ministry.

10. The implementing agency shall allow the representative of this Ministry or the independent agency appointed by this Ministry or the State Government to inspect actual working of the scheme.

11. No UC is due for rendition.
