Sir,

I am directed to convey the sanction of the President for release of an amount of Rs.3,16,00,000/- (Rupees Three Crore Sixteen Lakhs Only) as 2nd and final installment to the State Government of Rajasthan towards Grant-in-Aid (Creation of Capital Assets) under the Central Sector Scheme of **"Development of Particularly Vulnerable Tribal Groups"** for the year 2016-17 for the activities as per Annexure under Annual Plan for 2016-17.

2. The grant-in-aid shall be subject to provisions of GFR, 2005.
3. The works/activities shall be taken up in accordance with an implementation schedule drawn by Tribal Development Department of the State and submitted to the Ministry.
4. The Utilization Certificate for non-recurring and recurring grant will be submitted by the State Govt. to the Ministry as per Rule 212 of the GFR 2005 in Form GFR-19-A.
5. The State Government shall ensure that there is no unspent balance out of this grant left with them at the end of current financial year. The Unspent balance, if any, will be surrendered to the Ministry of Tribal Affairs.
6. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and for the welfare of members of PTGs only.
7. The financial assistance given to ITDPs/ITDAs and TRIs should be deemed to have been given to the State Government concerned and rules and regulation governing the grants-in-aid to States/UTs shall apply to them.
8. Physical and financial Progress in respect of activities to be undertaken in this regard shall be reported every quarter.
