**Sub: Release of Grants-in-aid to Government of Andhra Pradesh under the Centrally Sponsored Scheme of Post Matric Scholarships to the students belonging to Scheduled Tribes as arrear grant for the year 2016-17 during current financial year 2017-18.**

Sanction of the President of India is hereby conveyed to release an amount of **Rs.61,38,11,000.00 (Rupees Sixty One Crore Thirty Eight Lakh Eleven Thousand only)** to the State Government of **Andhra Pradesh as arrear grant for the year 2016-17 during current financial year 2017-18** under the Scheme of Post-Matric Scholarship to the students belonging to STs on reimbursement basis.


2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debitable to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2017-18:-


