Sub: Release of Grants-in-aid to Government of Chhattisgarh under the Centrally Sponsored Scheme of Post Matric Scholarships to the students belonging to Scheduled Tribes as arrear grant for the year 2016-17 during current financial year 2017-18.

Sanction of the President of India is hereby conveyed to sanction an amount of Rs.2184.28 lakh and to release an amount of **Rs.20,55,26,000.00 (Rupees Twenty Crore Fifty Five Lakh Twenty Six Thousand only)** after adjustment of unspent balance of Rs.129.02 lakh to the State Government of **Chhattisgarh as arrear grant for the year 2016-17 during current financial year 2017-18** under the Scheme of Post-Matric Scholarship to the students belonging to STs on reimbursement basis.


2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debitable to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2017-18:-

The State Government shall ensure that the Scholarship funds received from the Government of India/Ministry of Tribal Affairs are released directly to the beneficiaries electronically as laid down in Union Ministry of Finance's Office Memorandum No. I-11011/58/2013-DBT dated 27/08/2015. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of **Chhattisgarh** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.
