

3. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the KSTRI/State Government from time to time.

4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other purpose/activities.

5. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so

6. No Utilization Certificate (UC) has been rendered due and pending. The Utilization Certificate (UC) should be submitted as per Rule 239 of GFR in form 12-C in terms of GFR 2017.
