Subject :- Release of 1st Instalment of grants-in-aid for the year 2017-18 under Central Sector Scheme of "Support to Tribal Research Institute (TRIs)" to Tribal Research Institute , Govt. of Sikkim

Sir,

I am directed to convey the sanction of the President of India for sanction of **Rs.136.00 Lakhs and to release an amount of Rs.68.00 Lakhs (Rupees. Sixty eight lakhs only) as 1st Instalment of grants-in-aid for the year 2017-18 to , Tribal Research Institute** under the Central Sector Scheme of "Support to TRIs" for the activities approved by the Ministry as per Annexure enclosed.


2. The Payment of **RS. 68.00 lakhs/-** (Rupees Sixty eight lakhs only) to the government of Sikkim will be made by a draft in favour of Secretary, department of Finance, Govt. of Sikkim, Gangtok. The Drawing and Disbursing Officer of the Ministry of Tribal Affairs will present a bill for Rs. 68.00 to the Pay& Account Officer, Ministry of Tribal Affairs to enable him to issue the Draft.

3. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the TRI / State Government from time to time.

4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other purpose/activities.

5. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.

6. No Utilization Certificate (UC) has been rendered due and pending. The Utilization Certificate (UC) should be submitted as per Rule 239 of GFR in form 12-C in terms of GFR 2017.




