

SANCTION ORDER

Sanction of the President of India is hereby conveyed to incur an expenditure of Rs. 70,72,687/- (Rupees Seventy Lakhs Seventy Two Thousand Six Hundred and Eighty Seven Lakhs Only) towards payment of the fourth instalment being 30% of the total agreed amount of Rs. 2,98,98,839/- (Rupees Two Crore Ninety Eight Lakh Ninety Eight Thousand Eight Hundred and Thirty Nine Only) after imposing penalty (Rs. 8,96,965/- i.e., 10 % of fourth instalment Rs. 89,69,652/-) as delayed submission of consolidated report (hard copies and in pen drive). An amount Rs. 10,00,000/- is withheld from the 4<sup>th</sup> Instalment till the period of completion of post implementation support after uploading of On-line Monitoring Application in public domain, to M/s. Vayam Technologies Ltd., Thapar House, 124, Janpath, New Delhi-110001. The break-up of the amount is as under:
